Methodology

The fieldwork was conducted between 30 and 04 September 2023, with the sample of N = 1,001 Australian citizens aged 18 and older who were enrolled to vote. All respondents were recruited over online panel to fill quotas based on age, gender, location (AEC region), education and vote at the 2022 federal election. Rim weighting was used to apply interlocking weights for age, gender, education and location. The efficiency for these were weights was 94 per cent, providing an effective sample size of 937.

Based on this effective sample size, the margin of error (95 per cent confidence interval) for a 50 per cent result on the full sample is ± 3.2 per cent.

This is larger for subsets of the data. For instance, state-based breakdown of results have sample sizes of 322 for New South Wales, 255 for Victoria and 202 for Queensland. Using the weighting efficiency above, this results in effective margins of error of ± 5.6 , 6.3 and 7.1 per cent for these states, respectively; and results based on these and similar breakdowns should be interpreted conservatively.

Voice referendum questions were located immediately after the demographic and other questions used for screening and quotas, as well as House of Representatives vote intention.





Figure 1: Direction and certainty of vote intention at the Voice referendum, by vote at the 2022 Australian federal election, state of residence and AEC regions.




Figure 3: Estimated vote intention for the Voice referendum, by age and education.







Figure 5: Perception of which campaign is performing better, by vote at the 2022 Australian federal election, state of residence and AEC regions.






Figure 7: Reasons to support and oppose the Voice, all voters.

Figure 9: Reasons to support the Voice, by vote at the 2022 Australian federal election, state of residence and AEC regions.






Figure 11: Reasons to oppose the Voice, by vote intention at the referendum.




Figure 12: Reasons to oppose the Voice, by vote at the 2022 Australian federal election, state of residence and AEC regions.






Figure 13: Reasons to oppose the Voice, by demographic characteristics.




Figure 14: How exposure to arguments for and against shifts vote intention for the Voice referendum, by initial support.
